Professor Pasztor of the Department of Biology joined the meeting to respond to questions from the committee. She explained that admission to these graduate programs remained at the departmental level. Program stipulates that masters thesis may be done in Spanish, even though knowledge of Spanish is not an admission requirement. English-speaking students are required to take a course in Spanish that is not currently listed in the Required Courses for this program. Students would spend two semesters at McGill and most of the research would be completed in Panama.

SCTP tabled the proposals until write-offs from GSO and UPO are available. However, the following problem areas were identified.

- status of Spanish language courses (required or not)
- status of Smithsonian Tropical Research Institute (STRI) adjunct professors
- stipulation of travel costs
- length of time described for degree programs

McGill School of Environment

**Bay of Fundy Field Semester** (15 cr.)

Professor Gail Chmura of the Department of Geography joined the meeting to respond to the committee's questions. She explained that undergraduate students would take these courses in the fall semester of the last year of their program. The four Required Courses focus on appropriate environment and wildlife (history, culture, and ecology) particular to Atlantic Canada, with some lectures taking place in the field. Students targeted for this Field

Semester would be from the McGill School of Environment (MSE) and the Faculties of Science, Agricultural and Environmental Sciences, and Arts. The McGill Institute for the Study of Canada has committed financial support for the first year, subject to review in the second year, to this Field Semester. Professor Crago indicated that a

financial write-off was received from Mr. Réal Del Degan, University Planning Office, concerning the budget for

this Field Semester, which indicated: “self-funded” terminology throughout the program should be replaced by stage fee, as this is not a self-funded program; units offering the program must set one reasonably estimated fee and not a range of fees as suggested; and liability insurance should be considered and students should be requested to sign a waiver or be informed in writing of the specific liabilities.

SCTP requested changes:

- submit document on how Field Semester fits into minor and major programs (presented to McGill Institute for the Study of Canada)
- complete program proposal form for proposal, with layout of Required Courses (15 cr.) and signatures from all faculties involved
- include a layout of how students will take courses
- submit proposal to Admissions, Registrar’s and Recruitment Office [ARR] for write-off
- revised proposal should incorporate Mr. Del Degan’s suggestions and be submitted to SCTP under document number 00(1)-SCTP-03-39 REVISED (eight copies plus original)
