To initiate this process, the Academic Policy and the Senate Steering Committee a review of their own terms of reference; the results of these reviews ware mitted to the Senate Nominating Committee for consideration.

### STEERING COMMITTEE

The Senate Steering Committee is a Standing Committee of Senate charged with proposing Senate agendation and routine business matters.

SPECIFIC AREAS OF RESPONSIBILITY

The Committee shall:

- 1. Meet <u>approximately</u> one week prior to every Senate meeting.
- Review the Senate calendar of business including any follow up on matters arising from decisions and discussion at Senate. The Secretary-General provide a verbal report to the Steering Committee on follow-up from Senate decisions/discussion at each meeting.
